Financial Report McCarty financial report reflects that the SE district is in excellent shape with a **current overall balance of \$7454.11** report may be viewed online at http://www.ksmea.org/se Gary expressed concern that there are still **outstanding fees totaling over 80.00** and also cautioned that some clinician expenses were rather high for last year.
- IV. Reports from Chairs
 - A. HS Choral Russ Vallier last year, 385 auditioned, 157 made the district choir, and 27 schools participated. **Rager Moore of the University of Arkansas will be the clinician for December 2010**. Russ would like to add 2 more judges per room for auditions for a total of 5 choir judges per room, and throw out the high and low scores. The board will entertain a motion to this effect. New location is needed for November auditions Parsons High School is a possibility
 - B. HS Band Willey Abati Willey had to miss today's meeting and will get a report to us later
 - C. HS Jazz Larry Lillard **Gary Ziek from ESU will be the clinician** for our December 2010 event. Larry would like to see us give an award for one student from each SEKMEA honor group who distinguishes him/herself throughout the event. The board will entertain a motion regarding this.
 - D. HS/MS Orchestra Faye Millen Jane Williams of Ft. Scott has retired. We will certainly miss Jane, who has been an outstanding teacher in the SE district of KMEA for many years. She has built an excellent program at Ft. Scott, and her program has achieved many honors, including appearance at the KMEA State Convention. October Mass HS Orchestra event may happen this year (SE orchestra teachers will be the directors) and live auditions may occur at this time – otherwise, paper auditions will continue, and will be submitted on Saturday, November 6, when choir, band, and jazz band district auditions will take place. **Dr. Mark Laycock** will be this year's December clinician and music selections have already been made – February date for Mass MS Festival (65 students participated in this at Ft. Scott on a weekday last year. **Riverton has volunteered to host** this year) – Faye voiced **concerns** about Pittsburg school orchestra program not being supported currently one director has the responsibility for both the band and orchestra at Pittsburg. Fave would like to see a 1234A String Orchestra at

- the state KMEA convention. Faye reports that 27 students participated in last year's district honor orchestra and that one student from SE district was named to the State Festival Orchestra (3 SE district students auditioned). 4 SE schools and 65 students participated in the Middle School Mass Orchestra event on March 5, 2010 at Ft. Scott Middle School.
- E. MS Choral Pam McDaniel no clinician yet, but several possibilities are listed. MS Honor Choir online registration deadline is Friday, Nov. 12. Pam reports that last year's Middle School Honor Choir at Burlington included 154 students (54 sopranos, 52 altos, and 48 baritones), with 27 schools participating. She reports that Dr. Terry Crull, clinician, was "personable and dynamic, well-liked by the students".
- F. MS Band Jeff Russell set the MS Honor Band online registration deadline as Oct. 15. Suggestions included using director name tags, student name tags, student name tags in large letters on back of music stands for easy viewing by the conductor makeup of band will be 7th and 8th graders, not just 8th graders. Ray will get word to Troy Johnson that we are making this a 7th and 8th grade band and that the online form should specify that sectional rehearsals might be good (run by directors directors would specify their primary instrument on the registration form) music will be handed to directors at the November high school audition day. Jeff voiced concern that some students were "sight-reading" on the MS Honor Band day and ideas were discussed regarding how to convince directors to prepare their students more thoroughly. Russ suggested "spot-checks" in rehearsal and to let directors know this will happen Dean Davison of Louisberg will be Clinician next year for the January 2011 MS Honor Band event.
- G. Elementary Allison Russell 19 directors, 17 schools, 143 5th and 6th grade singers in the Elementary Honor Choir last January. **Karen Sims of Maize did an exceptional job working** with the group.
